### **Nuclear Verdicts**

Nuclear Verdicts are generally defined as when a jury award reaches and/or exceeds a rational amount, which is usually put at or over \$10 million. Over the past six years, there has been a 300% increase in verdict cases higher than \$1 million in the trucking industry, according to the American Transportation Research Institute (ATRI) Research Advisory Committee (RAC). As a repercussion of both award amounts and case quantity rising, insurance rates have spiked. As stated by the ATRI, "Over the last 2 to 5 years, commercial truck insurance premiums have increased annually between 35 percent and 40 percent for low-to average-risk carriers."

The main source of blame in these events has been the plaintiff attorneys' prices. The "little guy" versus the "big guy" concept has arisen, where the "big bad wolf" of giant corporations and law firms strive to take advantage of the everyday folk, such as truck drivers. However, as this situation grows bigger, it has not only affected companies and truck drivers but the everyday pedestrian driver, as well. If circumstances are to deescalate, the industry believes an awareness must be brought to these cases and their severity.
